The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Licensee Chi Anne Niemeyer, R.N., (dob April 11, 1978) is licensed in the State of Wisconsin as a professional nurse, having license number 168775-30, first issued on August 20, 2009 and current through February 29, 2016. Licensee's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 1814 Wolf Road, Waukesha, Wisconsin 53186-2644.

2. At all times relevant to this proceeding, Licensee was employed as a professional nurse at an assisted living facility (Facility), located in Glendale, Wisconsin.

3. On June 16, 2015, Resident A's physician ordered a decrease in the resident's Dilantin® and to keep Keppra® at the same dose.

4. Licensee correctly wrote the physician's orders down on Resident A's lab sheet to reduce Dilantin® from 7.5 ml BID to 6.5 ml BID and to keep Keppra® at the same dose of 7.5 mg Q 12 hours. However, Licensee incorrectly entered the orders into the computer and discontinued the Dilantin® and decreased Keppra® from 7.5 mg Q12 hours to 6.5 mg Q12 hours.

5. On June 22, 2015, Resident A suffered a grand mal seizure and had to be transported to the emergency room and was admitted to the intensive care unit.

6. In resolution of this matter, Licensee consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

#### ORDER

1. The attached Stipulation is accepted.

2. Within six (6) months of the date of this Order, Chi Anne Niemeyer, R.N., shall at her own expense take and successfully complete five (5) hours of education on the topic of documentation and six (6) hours of education on the topic of preventing medication errors as follows:

- a. Each course attended in satisfaction of this Order must be pre-approved by the Board or its designee. Licensee shall be responsible for locating course(s) satisfactory to the Board and for obtaining the required approval of the courses from the Board or its designee. Licensee must take and pass any exam offered for the course(s).
- b. Licensee shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any education requirements that have been or may be instituted by the Board or Department.

3. Within 120 days from the date of this Order, Licensee shall pay COSTS of this matter in the amount of \$100.00.

4. Request for approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Licensee to the Department Monitor at the address below:



Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Licensee is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.


8. The Division of Legal Services and Compliance joins Licensee in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
