You are hereby notified that your Dwelling Contractor and Dwelling Contractor Qualifier credentials are suspended for one week, effective November 30, 2015.

After the one week suspension, you may request to have your credentials reinstated. This request shall be in writing. The Department will impose the following conditions upon the reinstated credentials. You will have one year from the date of the reissued license to deliver to the Department proof that the judgment against you in Outagamie County Case No. 2015SC001021 is satisfied. If the Department does not receive proof that the judgment is satisfied within this one year period, your Dwelling Contractor and Dwelling Contractor Qualifier credentials will be suspended until the judgment against you is satisfied. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f).

You have the right to request a hearing on the suspension by sending a request for hearing to the Department, addressed to Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is November 24, 2015. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. Chapter 227.


The basis for these suspensions is activities you engaged in from approximately January through March 2015. You were hired, by the Complainant, to work on an alteration in a one-two family dwelling on or about January 14, 2015. No work was performed until approximately March 12, 2015, despite being initially scheduled to start approximately February 17, 2015. Little of the contracted work had been accomplished by March 24, 2015. When Complainant

asked for a refund, a refund was not granted. At that point in time, several payments had been made to you.

A civil court case was filed against you in Outagamie County on March 31, 2015, case number 2015SC001021. A judgment was filed on July 10, 2015 against you for \$6,115.07.

The above conduct constitutes misconduct under Wis. Admin. Code § SPS 305.10(1)(a)5. Misconduct includes financial misconduct under Wis. Admin. Code § SPS 305.003(43). This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305.
