On June 8, 2010, the Wisconsin Department of Safety and Professional Services (formerly known as the Department of Regulation and Licensing) issued an Order Granting Limited License ("Order"), which granted Applicant a limited real estate salesperson's license with certain terms and conditions.

On December 12, 2011, the Wisconsin Real Estate Examining Board suspended Applicant's real estate salesperson's license for failure to submit quarterly reports from his work supervisor and probation officer. The suspension was immediately stayed, and would remain stayed, as long as Applicant complied with the terms of the Order.

Information has been received that demonstrates Applicant has failed to submit work reports and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. The stay of suspension is removed and Applicant's real estate salesperson's credential (#74476-94) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
