On September 13, 2010, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Newell's cosmetology apprentice credential (80399-600), Respondent Newell's electrologist credential (756-84), and the cosmetology establishment credential for Respondent Spa at Riverfront, Ltd. (30256-80) with certain terms and conditions. On July 21, 2014, due to a change in the establishment's address, Respondent A Glo Spa & Salon Co. was granted a cosmetology establishment credential (41433-80) subject to the terms of the September 13, 2010 Order.

Respondents have submitted a request for removal of the limitations and the return of the above credentials to full, unrestricted status. Based upon the information of record, the Board's designee finds and makes the following:

ORDER

1. Respondent Newell's request for the return of her cosmetology apprentice (80399-600) and electrologist (756-84) credentials to full, unrestricted status is GRANTED.
2. Respondent Newell's request to return the cosmetology establishment credentials of Spa at Riverfront, Ltd. (30256-80) and A Glo Spa & Salon Co. (41433-80) to full, unrestricted status is hereby GRANTED.
3. This order is effective the date of its signing.
