On January 10, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.


On October 13, 2016, the Board considered Respondent's request for termination of the direct supervision requirement, access to controlled substances, and a reduction in drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for access to controlled substances is hereby GRANTED.
2. Respondent's requests for termination of the direct supervision requirement and a reduction in drug and alcohol screens are hereby DENIED due to insufficient time of compliance under the terms of the Order.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
