On July 10, 2013, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's dentistry license for 30 days, suspending his Class 1 and Class 2 sedation permits indefinitely, and limiting his license with other terms and conditions.

On May 18, 2015, the Board reinstated Respondent's Class 1 and Class 2 sedation permits with limitations specified in the Order.

On March 2, 2016, the Board considered Respondent's requests to modify the sedation limitations and mentor requirements. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for modification of sedation limitations is DENIED, Respondent must comply with the terms of the Order.
2. The Board MODIFIES provision 4b.ii.b. in that, if Respondent has not practiced conscious sedation on at least five patients in the preceding three months, Respondent's professional mentor shall review all patients who were sedated in the preceding three month period.
3. The Board REVOKES approval of Dr. Peter Hehli as Respondent's professional mentor. Respondent shall not perform any new sedations until he obtains a new mentor that is pre-approved by the Board.
4. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
5. This order is effective the date of its signing.
