On February 20, 2014, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") requiring Respondent to complete forty (40) hours of education in accordance with the continuing education requirements specified in Wis. Admin. Code § 135.02 within ninety (90) days and pay \$78.00 in costs of the proceeding within ninety (90) days. On October 20, 2015, Respondent's License was suspended for failure to complete the education and pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. The suspension is terminated and Respondent's home inspector license (#2002-106) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
