On September 11, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing, advanced practice nurse prescriber, and nurse-midwife credentials for an indefinite period. Respondent was granted an immediate stay of suspension and her credentials are currently limited with certain terms and conditions, including that she fully comply with all conditions and limitations placed on her Minnesota licenses.

Respondent has submitted proof that she successfully complied with all terms and conditions of the Minnesota Consent Order and that her Minnesota licenses are no longer conditional or limited in any way. Therefore, pursuant to the Order, the following is entered:

ORDER

1. Respondent's professional nursing (#117907-30), advanced practice nurse prescriber (#2202-33), and nurse-midwife (#137182-32) credentials are returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credentials are removed.
3. This order is effective the date of its signing.
