
On September 24, 2014, the Department of Safety and Professional Services (Department) granted Applicant a private security person permit with certain terms and conditions. Pursuant to the Order Granting Limited License issued on the same date (Order), Applicant may petition the Department for modification to the limitations after completing one year of practice in compliance with all terms and conditions.

Applicant has recently submitted a petition for termination of the limitation on her private security person permit to the Department for consideration. Based upon the information of record, the Department finds and makes the following:

1. Applicant's request for a full, unrestricted private security person permit (#50895-108) is hereby GRANTED.
2. All limitations and encumbrances upon Applicant's credential are hereby removed.
