
On November 5, 2014, the Department of Safety and Professional Services (Department) granted Applicant a limited substance abuse counselor in-training certificate in the state of Wisconsin. Pursuant to the Order Granting Limited SAC-IT Certification issued on the same date, the limitations imposed upon Applicant's certification shall remain in effect until the Department receives sufficient evidence to warrant removal of the restrictions.

On March 29, 2016, the Department considered Applicant's petition for full, unrestricted certification. Based on the information of record, the Department finds and makes the following:

ORDER

1. Applicant's request for full, unrestricted substance abuse counselor in-training certification (#17318-130) is hereby GRANTED.
2. All limitations and encumbrances upon Applicant's credential are hereby removed.
