On May 6, 2015, the Wisconsin Real Estate Appraisers Board issued a Final Decision and Order ("Order") requiring Respondent to complete ninety (90) hours of education on the topics specified in the Order, including taking and passing any exam offered for the courses, within six (6) months.

Respondent presented the certificates of attendance for the courses but the exams were not completed as required by the Order. Respondent was subsequently granted an extension to complete the required exams, which were to be taken and passed by February 29, 2016.

The information of record demonstrates that Respondent has yet to complete the education requirements in full and as a result the following is entered:

ORDER

1. Respondent's certified residential appraiser license (504-9) is hereby SUSPENDED.

2. The suspension shall remain in effect until Respondent has demonstrated successful completion of the education requirements of the Order.
