On July 9, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent was granted an immediate stay of suspension, contingent upon her full compliance with the terms and conditions of the Minnesota Board of Nursing's Stipulation and Consent Order dated February 5, 2015 (Minnesota Order).

Information has been received that demonstrates Respondent is not in compliance with the terms and conditions of the Minnesota Order, as evidenced by the suspension of her Minnesota nursing license on December 17, 2015. As a result, the following is entered:

ORDER

1. The stay of suspension is removed and Respondent's professional nursing license (#195153-30) is hereby SUSPENDED until further notice.
2. This order is effective immediately.
