On August 13, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to submit proof of successful completion of the education ordered by the Wyoming State Board of Nursing, which included 4.8 hours in disciplinary actions and two (2) hours in nurse practice acts.
