On October 7, 2015, the Department of Safety and Professional Services (Department) granted Applicant a limited substance abuse counselor in-training certificate in the state of Wisconsin. Pursuant to the Order Granting Limited SAC-IT Certification issued on the same date, the limitations imposed upon Applicant's certification shall remain in effect until the Department receives sufficient evidence to warrant removal of the restrictions.
