On October 8, 2015, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's practical nursing license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates that Respondent is in violation of the Order, as evidenced by Respondent's lack of compliance with all requirements for participation in drug monitoring. As a result, the following is entered:

1. Respondent's practical nursing license (#313724-31) is hereby SUSPENDED until further notice.
