The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Wilton C. Calderon, D.O. (dob May 29, 1970), is licensed in the state of Wisconsin to practice medicine and surgery, having license number 52734-21, first issued on March 4, 2009, with license voluntarily suspended pending an investigation and the final resolution thereof pursuant to an Interim Order dated October 21, 2015. According to the most recent address on file with the Wisconsin Department of Safety and Professional Services (Department), Dr. Calderon currently resides in Connecticut.

2. Respondent relocated his practice from Wisconsin to Connecticut in January, 2015.

3. On October 14, 2015, Respondent voluntarily stipulated to an Interim Order, which was adopted by the Board on October 21, 2015. The Order provided, in part, the following:

- a. Respondent was employed as a physician in Plover, Wisconsin and practiced family medicine between 2009 and January 2015.
- b. In January 2015, Respondent relocated his practice to New London, Connecticut.
- c. On July 31, 2015, the Department received a complaint alleging that:
  1. Respondent engaged in unprofessional conduct as defined by Wis. Admin. Code §§ Med 10.02(2)(zd) and (2)(p) (Nov. 2002); and
  2. Respondent engaged in unprofessional conduct as defined by Wis. Admin. Code §§ Med 10.03(2)(c), (2)(e) and (2)(f) (Oct. 2013).
- d. Respondent denied the allegations, but indicated a willingness to suspend his Wisconsin license because he did not intend to return to Wisconsin for the practice of medicine;

4. The Department subsequently opened 15 MED 262 for investigation.

5. Respondent has voluntarily agreed not to practice as a physician in Wisconsin pending the final resolution of the Department's investigation of 15 MED 262.

6. Because Respondent no longer practices in Wisconsin and because he does not intend to return to Wisconsin for the practice of medicine, Respondent wishes to surrender his license and consents to the entry of the following Conclusions of Law and Order in resolution of this matter.

7. Respondent denies any and all allegations of professional misconduct and entry into this Stipulation does not constitute an admission of wrongdoing.

#### CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 448.02(5).

#### ORDER

1. The attached Stipulation is accepted.

2. The SURRENDER of the license by Wilton C. Calderon, D.O., (license no. 52734-21) to practice medicine and surgery in the State of Wisconsin and the right to renew that license is hereby accepted, effective the date of this Order.


3. This surrender constitutes Respondent's permanent relinquishment of his medicine and surgery license and his right to practice medicine and surgery in the State of Wisconsin.

4. This Order is effective on the date of its signing.

STIPULATION

Division of Legal Services and Compliance Case No. 15 MED 262

Respondent Wilton Craig Calderon, D.O., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. Respondent seeks to surrender his Wisconsin medical license, Subsequent to Respondent relocating his practice to Connecticut, the Division of Legal Services and Compliance opened an investigation, which is currently pending. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Diane M. Welsh.


4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.


6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.


8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
