On November 11, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's certified residential appraiser license. Respondent was required to complete thirty (30) hours of education in "general appraiser market analysis and highest and best use", complete seven (7) hours of education in "comparative analysis" and complete seven (7) hours of education in "overview of real estate appraisers principles" pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's certified residential appraiser license (#1427-9) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
