On November 11, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's certified residential appraiser license. Respondent was required to complete fifteen (15) hours of education in "USPAP", complete fifteen (15) hours of education in "residential report writing and case studies" and complete thirty (30) hours of education in "residential sales comparison and income approach" pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

1. Respondent's certified residential appraiser license (1783-9) is returned to full, unrestricted status.
