
On November 11, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's Certified General Appraiser license. Respondent was required to complete (7) hours of education in "Subdivision Valuation" and (15) hours of education in "National USPAP" pursuant to the terms of the Order.
