On January 14, 2016, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to pay \$250 in costs of the proceeding within one hundred twenty (120) days and complete three (3) hours of education in “patient rights”, three (3) hours of education in “ethics and professionalism”, three (3) hours of education in “pain management” and four (4) hours of education in “ medication errors” within ninety (90) days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements. Therefore, the following is entered:

ORDER

1. Respondent’s nursing license in the state of Wisconsin (#132583-30) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
