On February 10, 2016, the Wisconsin Real Estate Appraisers Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s certified residential appraiser license. Respondent was required to complete fifteen (15) hours of education in “USPAP”, complete seven (7) hours of education in “ comparative analysis”, complete four (4) hours of education in “real estate appraisal supervisor/trainee” and eight (8) hours of education in “ANSI & measuring square footage appraiser’s edition” pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent’s certified residential appraiser license (#812-9) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
