On February 10, 2016, the Wisconsin Real Estate Appraiser Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s certified general appraiser license. Respondent was required to complete fifteen (15) hours of education in “USPAP”, complete seven (7) hours of education in “analyzing operating expenses” and complete thirty (30) hours of education in “general appraiser sales comparison” pursuant to the terms of the Order.
