PROCEDURAL HISTORY

On July 21, 2014, the Department opened this matter, 14 MED 169, against Respondent based on allegations of criminal conduct.

On September 17, 2014, the Medical Examining Board (Board) suspended Respondent's license (no. 34738-20) to practice medicine and surgery, pending final resolution of the Department's investigation in 14 MED 169.

The parties have agreed to the terms and conditions of the attached Stipulation as a Final Decision and Order in this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order:

FINDINGS OF FACT

- 1. Respondent Jan A. Doose (DOB January 3, 1965) is licensed and registered in the state of Wisconsin to practice medicine and surgery, having license number 34738-20, first issued on August 25, 1993, expired on October 31, 2015, and suspended on September 17, 2014 until the final resolution of this matter, 14 MED 169. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 4930 S. 18th Street, Milwaukee, WI 53221. Respondent was formerly known as Jan A. Doenier, and began using her maiden name, Doose, while this matter was pending.
- 2. In 2014, Respondent became the subject of Waukesha County case numbers 14-CF-452, 14-CF-897, 14-CM-570, and 14-CM-764, and a City of Pewaukee municipal citation.
- 3. The complaints in the above-described matters allege facts, criminal and civil violations which raise significant concerns about Respondent's mental health and substance abuse, specifically alcohol.
- 4. The above-described court cases have all been resolved, but while they were pending, Respondent agreed to a suspension of her license to practice medicine and surgery until the final resolution of this matter, 14 MED 169.
- 5. On September 17, 2014, the Board entered Interim Order 0003415 suspending Respondent's license to practice medicine and surgery. Interim Order 0003415 has remained in effect since it was entered.
- 6. Respondent has chosen to voluntarily leave the practice of medicine due to medical reasons and thus let her license to practice medicine and surgery (34738-20) expire as of October 31, 2015. However, Respondent may wish to return to the practice of medicine and therefore consents to entry of the following Conclusions of Law and Order to resolve 14 MED 169.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

- 1. The Stipulation of the parties is accepted.
- 2. Interim Order 0003415 suspending the Wisconsin medicine and surgery license issued to Respondent Jan A. Doose (f/k/a Jan A. Doenier) M.D., (license number 34738-20) is RESCINDED.

- 3. The right to renew the Wisconsin medicine and surgery license issued to Respondent Jan A. Doose (f/k/a Jan A. Doenier) M.D., (license number 34738-20) is SUSPENDED for an indefinite period.
- 4. The suspension may be fully or conditionally lifted, stayed, or continued at the sole discretion of the Wisconsin Medical Examining Board on petition by Respondent Jan A. Doose (f/k/a Jan A. Doenier) M.D., after Respondent complies with the terms of this Order.
- 5. Within ninety (90) days prior to submitting a petition for reinstatement, Respondent shall undergo an evaluation or evaluations by a professional or professionals qualified to determine whether or not Respondent is affected by a mental health condition and/or an AODA condition which renders Respondent unable to safely practice medicine and surgery.
 - a. Before undergoing the evaluation(s), Respondent shall submit to the Department Monitor current curriculum vitae for each proposed evaluator, along with copies of their professional license(s) and certifications held.
 - b. The evaluator(s) must be licensed and board certified in a relevant field of practice. At the discretion of the Board's designee, additional experience in a relevant field of practice may be substituted for Board certification. At the discretion of the Board's designee, alternate Board recognitions, such as fellowships, may also be substituted for Board certification.
 - c. The evaluator(s) must have had no previous personal or professional relationship with Respondent, and may not have previously evaluated or treated Respondent.
 - d. The evaluator(s) shall have had a minimum of ten (10) years of experience in their field of practice, and may not have been previously disciplined by any credentialing authority.
 - e. Each evaluator is responsible for the final evaluation, but may delegate testing or other components of their evaluation to other mental health professionals who the evaluator(s) deems competent to perform the delegated task.
 - f. Evaluation methods are within the discretion of the evaluator(s), but must include a comprehensive interview of Respondent, and must be generally recognized and accepted in their field of practice.
 - g. The evaluation(s) shall include an assessment of Respondent's ability to appropriately manage the triggers, degrees, and effects of an angered emotional state.

- h. Within thirty (30) days of the completion of the evaluation(s), a written report regarding the results of each evaluation shall be submitted to the Department Monitor.
- i. The evaluator(s) shall identify restrictions on the nature of practice or practice setting or requirements for supervision of practice, if any, which are necessary to render Respondent able to practice medicine and surgery with reasonable skill and safety.
- j. The evaluator(s) shall identify specific mental health and AODA treatment goals, if any, which must be met before Respondent is able to practice medicine and surgery with reasonable skill and safety.
- k. The opinions and conclusions of the evaluator(s) must be rendered to a reasonable degree of professional certainty.
- 1. Respondent must provide the evaluator(s) with a copy of this Order.
- m. Respondent shall authorize the evaluator(s) to receive all records of mental health and AODA evaluations, diagnosis, and treatment that Respondent has undergone since January 1, 2014, and such other records the evaluator(s) deem necessary for a complete evaluation.
- n. Respondent shall authorize the evaluator(s) to discuss the results of the evaluation with the Board or its designee.
- 6. Upon successfully completing the mental health and AODA evaluations described in paragraph 5 above, or as otherwise approved by the Board's designee, Respondent shall undergo and fully cooperate with an assessment establishing her clinical competence to safely practice medicine and surgery, by an assessment program acknowledged by the Federation of State Medical Boards and preapproved by the Board or its designee.
- 7. Respondent shall provide the clinical competence evaluator with a copy of this Order, and shall authorize the Board or its designee to communicate freely with the clinical competence evaluator, and to receive and use the evaluator's final report for the Board's purposes.
- 8. Respondent shall complete, to the satisfaction of the Board or its designee, all education and training recommended by the clinical competence evaluator before the Board will decide to grant, conditionally grant, or deny Respondent's petition for reinstatement.
- 9. Respondent shall be responsible for all costs associated with the evaluations required under this order, including all additional evaluations, treatment, education and training, as may be recommended by the evaluators.

- 10. If and when Respondent Jan A. Doose (f/k/a Jan A. Doenier) M.D., petitions for reinstatement of licensure, she shall, as a prerequisite, pay the COSTS of this matter in the amount of \$1,200.00 before any such petition may be considered.
- 11. Payment of costs (made payable to the Wisconsin Department of Safety and Professional Services), requests for approval of evaluators, and any petition for reinstatement shall be sent by Respondent to the Department Monitor at the address below:

- 12. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in the revocation of Respondent's right to renew her license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.
 - 13. This Order is effective on the date of its signing.

STIPULATION

Respondent Jan A. Doose (f/k/a Jan A. Doenier) M.D., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Sydne French.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
