

You are hereby notified that your HVAC Contractor credential is suspended for two weeks, effective July 2, 2016. After the two week suspension, your credential will remain suspended until you apply to have your credential reinstated. This request shall be in writing. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f).

You have the right to request a hearing on the suspension by sending a request for hearing to the Department, addressed to Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is June 2, 2016. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.

The basis for this suspension is the hiring of Jamie Rousar to install plumbing at the Dancing Oaks Senior Housing Community. Both yourself and Rousar stated that he was employed with you during your work on this site. Rousar stated he installed plumbing at the site at your request; numerous other individuals witnessed him installing plumbing. This conduct is negligent, under Wisconsin Admin. Code § SPS 305.10(1)(a)3., as hiring an unlicensed individual to install plumbing represents a failure to exercise the degree of care and judgement to protect public health normally expected of a license holder.
