On July 27, 2016, the Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") suspending Respondent's social worker certification for an indefinite period. Respondent has been granted a stay of suspension and her certificate is currently limited with certain terms and conditions.

Information has been received that demonstrates Respondent is in violation of the terms of the Order and, as a result, the following is entered:

ORDER

1. The stay of suspension is removed and Respondent's social worker certification (#7845-120) is hereby SUSPENDED until further notice.
2. Respondent may petition the Section or its designee for reinstatement of the stay upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent three (3) months.
3. This order is effective immediately.
