FINDINGS OF FACT

1. On or about March 16, 2011, the State of Wisconsin Medical Examining Board (Board) issued Final Decision and Order LS 09052010 Med (Order) suspending Respondent's license (# 33210-20) to practice Medicine and Surgery for an indefinite period. Respondent has been granted a stay of the suspension and his license is currently limited with certain terms and conditions.
2. On or about September 12, 2016, Respondent informed the Board that he wished to surrender his license.
3. As of the date of this order, a check of the Department of Safety and Professional Services records show that Respondent does not have any complaints or other disciplinary actions pending. See Wis. Stat. § 448.02(5) and 440.19.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. §§ 448.02(1), 448.02(3), 448.02(5), and 440.19, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. §§ 15.08(5)(c) and 227.44(5).
2. The SURRENDER of credential number 33210-20 issued to JONATHAN W THOMAS, M.D., to practice as Medicine and Surgery in Wisconsin is ACCEPTED.
3. In the event Respondent petitions the Board for reinstatement, licensure, or registration, the Board may enter an order denying such petition without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license shall be in the discretion of the Board.
4. Respondent shall immediately return all indicia of Wisconsin Medical licensure and registration to the Department Monitor at the address below:
