FINDINGS OF FACT

- I. NATHAN DITSCH (Applicant) has filed an application to renew his Wisconsin private security person permit (# 1883-108).
- II. Information received in the application process reflects that the Applicant has the following violations and criminal convictions:
 - A. On or about November 3, 1994 Operating While Intoxicated, 1st, an ordinance violation.
 - B. On or about November 30, 1999 Operating While Intoxicated, 2nd, a misdemeanor.
 - C. On or about February 9, 2015 Operating While Intoxicated, 3rd, a misdemeanor.
 - i. You were sentenced to have your driver's license revoked for 27 months and, upon licensure, 27 months of ignition interlock device.
- III. Information on file establishes that you did not report the February 9, 2015 conviction to the Department within 48 hours after the entry of the judgment of conviction, as required by Wis. Stat. §§ 440.26(4m)(b), 440.03(13)(am), and Wis. Admin. Code §§ SPS 35.01(2) and SPS 4.09(2).

IV. You reported this conviction to the Department on or about August 8, 2016. Pursuant to that report, the Department then opened a case for investigation.

CONCLUSIONS OF LAW

- I. The Wisconsin Department of Safety and Professional Services has jurisdiction over this matter pursuant to Wis. Stat. § 440.26.
- II. The facts and circumstances of the violations and convictions referenced above substantially relate to the practice of a private security person. Applicant, by his conduct, is subject to action against his license, pursuant to Wis. Stat. § 440.26.

ORDER

NOW, THEREFORE, IT IS ORDERED that NATHAN DITSCH'S request to renew his PRIVATE SECURITY PERMIT is GRANTED, subject to the following LIMITATIONS, TERMS AND CONDITIONS:

Practice Limitations

- 1. Applicant shall show a copy of this order to his current and any future employers.
- 2. Applicant shall not drive any motor vehicle that requires a Department of Transportation (DOT) issued license for the purposes of his employment.

Reporting Requirements

- 3. It is Applicant's responsibility to arrange for his security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, beginning 90 days from the date of this Order. These reports shall describe the Applicant's activities and verify that he is in compliance with the laws governing the practice of a private security person and the terms of this Order.
- 4. Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change. In addition, Applicant shall report any arrest or conviction within 48 hours of the arrest or judgment of conviction.
- 5. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others.
- 6. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

7. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Petitions for Modification

8. Applicant may petition the Department for modification of the terms of this Order after completion of one year of practice in compliance with all terms and conditions of this Order. Applicant's petition must include his history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment, and, if applicable, his treatment provider expressly supporting the specific modifications sought. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stat. §§ 227.01(3), or 227.42, or Wis. Admin. Code ch. SPS 1, and shall not be subject to any right to further hearing or appeal.

Costs

9. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Summary Suspension/Discipline

10. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's license. The Department, in its discretion, may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that the Applicant fails to submit quarterly reports as ordered, Applicant's license may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of this order.
