Your actions violated Wis. Stat. § 145.06(1)(a) and Wis. Admin. Code § SPS 305.90(1)(a). The administrative forfeiture of \$1000.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125(1)(b)1.
