FINDINGS OF FACT

1. JOSEPH MIGGINS (Applicant) has filed an application to renew his Wisconsin private security person permit (#45473-108).
2. Information received in the application process reflects that, on or about October 20, 2015, you plead guilty and entered into a deferred prosecution agreement for the following crimes:
 - A. Negligent Operation of Motor Vehicle, a class A misdemeanor.
 - B. Fourth Degree Sexual Assault (2 counts), both class A misdemeanors.
3. On February 9, 2016, you were accepted into the Deferred Prosecution Program with the Dane County District Attorney's Office. You signed a contract with specific conditions that is scheduled to terminate on February 5, 2018.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Safety and Professional Services has jurisdiction over this matter, pursuant to Wis. Stat. § 440.26.
2. The facts and circumstances of the above-referenced substantially relates to the practice of a private security person. Applicant, by his conduct, is subject to action against his license, pursuant to Wis. Stat. § 440.26.

ORDER

NOW, THEREFORE, IT IS ORDERED that JOSEPH MIGGINS is GRANTED a RENEWAL FOR A PRIVATE SECURITY PERMIT subject to the following LIMITATIONS, TERMS, AND CONDITIONS:

Practice Limitations

1. Applicant shall show a copy of this order to his current and any future employers.

Reporting Requirements

2. It is Applicant's responsibility to arrange for his security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, beginning 90 days from the date of this Order. These reports shall describe the Applicant's activities and verify that he is in compliance with the laws governing the practice of a private security person and the terms of this Order.
3. Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change.
4. Applicant shall report any arrest or conviction within 48 hours of the arrest or entry of conviction.
5. Applicant shall report any violation of the terms of the deferred prosecution agreement within 48 hours.
6. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

7. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Petitions for Modification

8. Applicant may petition the Department for modification of the terms of this Order after completion of two years of practice in compliance with all terms and conditions of this Order or until successful completion of the above-referenced deferred prosecution agreement.
9. Applicant's petition must include his history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling two years of practice covering or until successful completion of the deferred prosecution agreement.
10. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment, and, if applicable, his treatment provider expressly supporting the specific modifications sought. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stats. §§ 227.01(3), or 227.42, or Wis. Admin. Code § SPS 1, and shall not be subject to any right to further hearing or appeal.

Costs

11. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Summary Suspension/Discipline

12. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's license. The Department, in its discretion, may, in the alternative, impose additional conditions and limitations or other discipline for a violation of any of the terms of this Order. In the event that the Applicant fails to submit quarterly reports as ordered, Applicant's license may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of this order.
