On November 7, 2003, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Licensee's professional nursing license with certain terms and conditions. Licensee's professional nursing license was suspended on March 12, 2004 for failure to comply with the requirements of the Order.

On May 18, 2009, the Board reviewed Licensee's request for reinstatement of her professional nursing license. In lieu of the reinstatement, the Board issued a limited license for the sole purpose of completing an approved nurse refresher course. The Board further ordered that upon successful completion of the course, Licensee's license shall be reinstated. Licensee's license was subsequently changed from "limited" to "regular" status on April 16, 2010 without issuance of an order granting full licensure by the Board.

On January 12, 2017, the Board considered Licensee's request for acknowledgment of her completion of an approved refresher course and confirmation that her professional nursing license has been returned to full, unrestricted status. Based on the information of record, the Board finds and makes the following:

ORDER

1. The Board hereby acknowledges Licensee has submitted proof that she successfully completed an approved nurse refresher course in December 2009.
2. Furthermore, pursuant to the May 18, 2009 Order, Licensee's professional nursing license (#136257-30) was reinstated to full, unrestricted status as of April 16, 2010.
3. This order is effective the date of its signing.
