On May 14, 2010, the Wisconsin Board of Nursing ("Board") issued an Order Granting Reinstatement of Licensure with Limitations ("Order"), reinstating Respondent's professional nursing license after revocation, and indefinitely suspending it. Respondent has been granted a stay of suspension with certain terms and conditions.

On September 14, 2017, the Board considered Respondent's request for full licensure or in the alternative, termination of direct supervision and reduction in drug screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for full, unrestricted licensure or termination of direct supervision and reduction in the frequency of drug and alcohol screens is hereby DENIED for failure to demonstrate continuous and successful compliance. Respondent needs to fully comply with the complete terms and conditions of the original Board Order (05/14/2010).
2. This order is effective the date of its signing.
