On December 3, 2009, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension, and her license is currently limited with certain terms and conditions.

On September 14, 2017, the Board considered Respondent's request for full licensure, or in the alternative, termination of treatment, reduction in drug and alcohol screens, and reduction in AA/NA meetings. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of the treatment requirement, reduction in the frequency of drug and alcohol screens, and reduction in the frequency of AA/NA meetings is hereby GRANTED. Respondent's frequency is reduced to not less than thirty-six (36) drug and alcohol screens per year, and one (1) AA/NA meeting per week.
2. Respondent's request for full, unrestricted licensure is DENIED. Respondent needs to practice nursing under the conditions of the modified Board Order before the Board will consider amending other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
