On September 13, 2010, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondents to pay costs of the proceeding in the amount of \$1,215 and forfeitures in the amount of \$700, in installments of \$400 due every 90 days. On April 27, 2011, the cosmetology establishment licenses for Choates Sport Cuts, Inc. and Sportcuts were suspended for failure to pay the costs of the proceeding and forfeitures as ordered. The establishment license for Choates Sport Cuts, Inc. has since lapsed.

Based upon the information of record, which includes proof that the costs of the proceeding and forfeitures have been paid in full, the following is entered:

ORDER

- 1. The suspension of Respondent Sportcuts' cosmetology establishment license (#35199-80) is terminated.
 - 2. This order is effective the date of its signing.
