On January 26, 2012, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On April 13, 2017, the Board considered Respondent's request for access to controlled substances, termination of direct supervision, and a reduction in drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for access to controlled substances is hereby GRANTED.
2. Respondent's request for termination of direct supervision and a reduction in drug and alcohol screens is hereby DENIED. Respondent must practice under the conditions of the modified Order before the Board will consider amending other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
