
On September 12, 2012, the Wisconsin Pharmacy Examining Board (Board) issued a Final Decision and Order (Order) suspending Respondent's pharmacist license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On July 20, 2017, the Board considered Respondent's request for an increase in pharmacist-in-charge (PIC) hours and a reduction in drug and alcohol testing frequency. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for an increase in PIC hours is hereby GRANTED. Respondent may work up to 40 PIC hours in any given seven (7) day period.
2. Respondent's request for a reduction in urine screens is hereby DENIED. Respondent must practice under the conditions of this Order before the Board will consider amending other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
