On March 10, 2014, the Wisconsin Board of Nursing ("Board") issued an Order Granting Original Limited License ("Order"), which reinstated Applicant's previously surrendered nursing license. Applicant's license was indefinitely suspended upon reinstatement and the suspension was subsequently stayed, contingent upon Applicant's compliance with the terms and conditions of the Order.

Information received demonstrates that Applicant is no longer participating in a drug and alcohol monitoring program. Applicant is therefore in violation of the terms of the Order and, as a result, the following is entered:

ORDER

1. The stay of suspension is removed and Applicant's professional nursing license (#187005-30) is hereby SUSPENDED until further notice.
2. Applicant may petition the Board or its designee for reinstatement of the stay upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent three (3) months.
3. This order is effective immediately.
