On July 14, 2016, the Wisconsin Board of Nursing (“Board”) removed Respondent’s stay of suspension for violation of the Final Decision and Order dated November 13, 2014 (“Order”). ORDER

1. The suspension of Respondent’s professional nursing and advanced practice nurse prescriber’s licenses (#101677-30 & 3299-33) is hereby STAYED.
