On December 11, 2014, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s nursing license for an indefinite period. On July 22, 2015, Respondent was granted an initial stay of suspension as long Respondent remains in compliance with the provisions of Sections C and D of the Order. On November 9, 2016, Respondent’s stay of suspension was removed due to non-compliance..

On February 9, 2017, the Board designee considered Respondent’s request for a stay of suspension. Based upon the information of record, the Board designee finds and makes the following:

ORDER

1. Respondent’s request for a stay of suspension is hereby DENIED. Respondent has not shown proof of successful compliance for the most recent three (3) consecutive months with Sections C and D of the Order.
2. This order is effective the date of its signing.
