On April 9, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's nursing license for an indefinite period.

On January 13, 2017, Respondent submitted a petition requesting a temporary reduction in drug screens and to receive a stay of suspension. Based upon the information of record, the Board Liaison finds and makes the following:

ORDER

1. Respondent's request for a temporary reduction in drug screens is hereby GRANTED. Respondent will be tested at not less than 14 screens per year and one hair test. Once Respondent has obtained pre-approved employment, screens will increase back to 49 screens per year.

2. Respondent's request for a stay of suspension is hereby DENIED. Respondent has not shown proof of successful compliance for the most recent three (3) consecutive months of sections C and D of the original Order (4/9/2015).

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
