On May 20, 2015, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's medicine and surgery license for an indefinite period. Respondent has been granted a stay of suspension, and his license is currently limited with certain terms and conditions.

On August 16, 2017, the Board considered Respondent's request for a reduction in drug and alcohol screens and termination of the mentor requirement. Based upon the information of record, the Board finds and makes the following:

## <u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens, and termination of the mentor requirement is DENIED due to failure to demonstrate continuous and successful compliance under the terms of the Order (5/20/2015).
