On April 20, 2016, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery indefinitely. Pursuant to the Order, Respondent was required to provide proof satisfactory to the Board or its designee that he is in compliance with the continuing education requirements for the 2014-2015 biennium. Respondent was also required to show proof that he has completed 30 hours of acceptable continuing education to be applied to the 2012-2013 biennium.

Based upon the information of record, which includes proof that Respondent has completed the required education for both bienniums, the following is entered:

ORDER

1. The suspension of Respondent's license to practice medicine and surgery (#53700-20) is hereby terminated.
2. All limitations and encumbrances imposed upon Respondent's credential pursuant to the Order are removed.
3. This order is effective the date of its signing.
