On May 9, 2016, the Wisconsin Chiropractic Examining Board issued a Final Decision and Order ("Order") limiting Respondent's chiropractic license. Respondent was required to submit written notification to Medicare, Medicaid, all third-party payers, and to each patient who personally paid fees for chiropractic services during the period of June 26, 2013 through February 27, 2014. Respondent was then required to submit a sworn affidavit to the Department pursuant to the terms of the Order.

1. Respondent's chiropractic license (#3425-12) is returned to full, unrestricted status.
