
On May 10, 2016, the Department of Safety and Professional Services (Department) granted Applicant a private security person permit with certain terms and conditions. Applicant has recently submitted a petition for termination of the limitations on his private security person permit to the Department for consideration. Based upon the information of record, the Department finds and makes the following:
