
On July 7, 2016, the Wisconsin Department of Safety and Professional Services (“Department”) issued a Final Decision and Order (“Order”) suspending Respondent’s clinical substance abuse counselor certificate for an indefinite period. Respondent may petition for a stay of suspension upon compliance with Sections C and D of the Order for the most recent three months.

Respondent’s petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Respondent’s clinical substance abuse counselor certificate (#15706-132) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent’s compliance with the terms and conditions of the Order.
3. This order is effective the date of its signing.
