On August 3, 2016, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") suspending Respondent's professional counselor license for at least one year. During the period of suspension, Respondent was to engage in counseling at least monthly for a period of 12 consecutive months, commencing March 14, 2016.

Respondent has recently submitted a petition for termination of the suspension and the counseling limitation on her professional counselor license for consideration. Based on the information of record, the Section designee finds and makes the following:

ORDER

1. The suspension of Respondent's professional counselor license (#4692-125) is hereby terminated and the license is returned to full, unrestricted status.
2. All limitations and encumbrances imposed upon Respondent's credential pursuant to the Order are removed.
3. This order is effective the date of its signing.
