On February 16, 2017, the Wisconsin Board of Nursing ("Board") issued an order in response to Respondent's request to terminate the suspension of his professional nursing license. Due to a scrivener's error, the order was incorrectly captioned, "Order Denying Stay of Suspension," and incorrectly stated that Respondent's license was indefinitely suspended pursuant to the Final Decision and Order dated September 8, 2016.

The February 16, 2017 Order is hereby correctly captioned, Order Denying Termination of Suspension, and shall read as follows:

On September 8, 2016, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's nursing license (#163709-30) with certain terms and conditions. On November 16, 2016 Respondent's license was suspended for violation of the Order.

On February 13, 2017, the Board designee considered Respondent's request to terminate the suspension. Based upon the information of record, the Board designee finds and makes the following:

ORDER

1. Respondent's request for termination of the suspension is hereby DENIED.
2. This order is effective February 16, 2017.
