On September 8, 2016, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On September 14, 2017, the Board considered Respondent's request to have Florida Intervention Project for Nurses ("Florida IPN") assume full monitoring responsibilities for Respondent as outlined in the written agreement between the Wisconsin Department of Safety and Professional Services ("Department") and Florida IPN. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request to have Florida IPN assume full monitoring responsibilities for Respondent as outlined in the written agreement between the Department and Florida IPN is hereby GRANTED.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
