On September 14, 2016, the Wisconsin Department of Safety and Professional Services ("Department") granted Applicant a private security person permit with certain terms and conditions. Pursuant to the Order Granting Limited License issued on the same date ("Order"), Applicant may petition the Department for modification to the limitations after completing one year of practice in compliance with all terms and conditions.

Applicant has recently submitted a petition for termination of the practice limitations and reporting requirements on his private security person permit to the Department for consideration. Based on the information of record, the Department finds and makes the following:

ORDER

1. Applicant's request for a removal of the practice limitation from provision one and reporting requirements from provisions three through five has been GRANTED.
2. The firearms ban provisions two and seven through nine shall remain in full force and effect. This limitation may not be modified at any time.
3. This order is effective the date of its signing.
