
On September 15, 2016, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") limiting Respondent's clinical substance abuse counselor certificate with certain terms and conditions. Pursuant to the Order, Respondent's certificate may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to comply with all requirements for participation in drug and alcohol monitoring established by the approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent's clinical substance abuse counselor certificate (#15422-132) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
