On October 13, 2016, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's nursing license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to have an AODA assessment and mental health/fitness for duty assessment completed and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent's nursing license (#313515-31) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
